## STAR 99.9's Goodwill Night at a Concert at Hartford HealthCare Amphitheatre Contest Rules

## OFFICIAL RULES

4. <u>Winner Selection and Odds</u>. On or about June 2<sup>nd</sup>, 2025, Sponsor will select one (1) potential Grand Prize winner in a random drawing from among all Finalists.
