

STAR 99.9 FRANK PEPE PIZZERIA MIAMI SLICE DUA LIPA FLYAWAY

OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, the **STAR 99.9 FRANK PEPE PIZZERIA MIAMI SLICE DUA LIPA FLYAWAY** (the "Sweepstakes") is open to residents of the state of Connecticut who are 21 years or older at the time of entry". To enter: Listen to Anna and Raven Weekdays between 9am and 10am on Star 99.9 FM during the contest period for the DUA LIPA montage. When it's played be the 10th caller to 800-330-9999 to be qualified to win or enter in person at Frank Pepe Pizzeria locations in Connecticut during regular business hours, Scan the QR code and text the code to 800-330-9999 to be entered to win. Enter as often as you like provided that multiple entries by means of software-generated or other automated processes will be disregarded.

In order to claim a prize, potential winner must respond to Sponsor's notification within 24 hours of notice or attempted notice.
